President's Report – Ordinary Meeting 6th May 2015

Campus Wifi

I have been in contact with Steve Junor, the person responsible for the University's Wireless. We have been working to improve the signal on campus in areas such as Bosch Lecture Theatres, Old Teachers' College, The Main Quadrangle, and low signal areas of Eastern Ave. I have put out posts and Honi Soit reports appealing to students for advice regarding other areas where there is a need for a stronger wifi signal. If there are any other suggestions please let me know.

Undergraduate Studies Committee

There were changes to the late submission policy for the Faculty of Architecture, Design and Planning.

Previously late submissions would mean a 35% penalty on the 1st day an assignment is submitted late with 50% after 3 days. If the assignment was not submitted after 10 working days, the student would receive a mark of 0.

As of 2nd Semester, the policy will be that late submissions will receive a 5% penalty per calendar day for written submissions and 10% per calendar day for visual/public/oral presentations.

Business School: There was also a brief debate about the way Honours is advertised to students in terms of it being research-based or looking for the "best and brightest". This came after employers were calling the Business School encouraging academics to not bother with asking students if they were interested in pursuing Honours as they did not believe it was necessary to them anymore.

I argued that students should be encouraged to take up research based Honours if they wish as it empowers students to be able to follow their interests and be well informed with what their careers will entail after they graduate rather than having an imbalanced knowledge hierarchy between employees and employers. As a result of limited time in this committee meeting the debate was held over.

DTP (Diploma of Tertiary Preparation)

To my understanding, the University had cut this from its program. It then became apparent through the media that there were at least 4 people who were able to gain entry into the University through

this program. When I questioned this I was told that these people had already received acceptance letters and the University could not retract its stance. To my understanding, the DTP is now wiped from the University and not students from schools who participate in this program will be accepted under it.

Anti Semitism on Campus

As you are aware, the Vice-Chancellor has taken a strong approach towards those who participate in actions regarding the Israel and Palestine conflict. I have released numerous reports, media released, and spoken out against the accusation of anti-Semitism on campus including last weeks Public Meeting in the General Lecture Theatre. I will also be following this up at Student Consultative Committee after the Vice-Chancellor cancelled the Anti-War Event (which was supposed to be held on the 26th April). This was apparently a result of threats made to the University from members of the far-right movements, including the Reclaim Australia Group. I will be asking the Vice-Chancellor what his view is on freedom of speech is and if there was a difference between allowing an event defending Israel to continue and cancelling an event towards an Anti-War approach even though both the left and the right were commenting on both.

Kyol Blakeney added to his report at the meeting

Kyol Blakeney: I had a few things to raise with the VC today at SCC in regards to anti-Semitism on campus, he was not there so I have arrange a meeting with him for next week.

SRC Budget Notes 2015

This budget proposal is the result of extensive consultation, especially over the past 2 months, with:

- SRC administrative, casework, publications and legal staff, who contributed to the SRC's funding request for the Student Services Amenities Fee (SSAF) and were subsequently consulted regarding funding arrangements once the 2015 distribution of the SSAF was announced;
- SRC Office Bearers,
 who were all invited to submit funding proposals detailing their projects for the year
 and how much they anticipated they would spend, and to meet with us to discuss
 how these proposals would be reflected in the budget; and
- the National Union of Students (NUS), through our attendance at conferences (such as NUS National Conference, which we both attended, and Presidents' Summit, which Kyol attended) and regular communication with National Office Bearers.

We think the budget successfully balances the interests of the SRC in the long and short terms. We are happy to submit a budget that is balanced to ensure the SRC's financial sustainability, increases funding to Office Bearers, Caseworkers and the SRC Legal Service, and avoids drastic reductions in funding to any of our commitments now and in the next few years.

The SRC's SSAF Allocation in 2015

The total amount that the SRC will receive from SSAF this year is \$1,651,750. This is an increase of 9.4% on the SRC's allocation of \$1,510,000 in 2014. To our knowledge this is the largest increase in funding awarded to any of the student organisations this year.

We are unable to distribute the SRC's SSAF proposal and other submissions we prepared for SSAF negotiations this year, but we are happy to show these to Representatives and Office Bearers in person.

Future Funding for the SRC

Regrettably, our annual election cycle tends to limit the amount of consideration the SRC gives to its future and, in particular, its long term funding. This section is intended to place our 2015 budget decisions in the context of a much-needed discussion around ensuring funding for the next few years and how the organisation might respond if its funding is threatened.

For context, the budget deficit in 2013 was ~\$40,500 and in 2014 was ~\$65,000. The proposed budget aims to match the SRC's spending to its income as closely as possible (though, like last year, unforeseen costs will likely result in a small deficit). We think this is the right move for the reasons outlined below.

Our funding is unlikely to continue increasing at the same rate as the last few years. If we spend as if it will then future General Secretaries will be forced to make significant savings (likely to NUS affiliation and Office Bearer budgets as they represent the majority of non-fixed costs for the SRC) or find alternative income. There are several things to note about current and future funding:

1. The substantial increase that the SRC received this year should be regarded as a one-off spike in funding that is unlikely to be repeated for a number of years. There are a number of reasons for this. First, the SRC made concessions in 2014's SSAF negotiations to assist SUPRA in gaining a significant and sorely needed increase. There was some understanding, then, that SUPRA would use its stable financial position from 2014 to assist the SRC in achieving a large increase this year. This benefited the SRC this year but is unlikely to be a factor in the future. Second, the total amount of SSAF funding grew by 4.5% from 2014 to 2015. Our increase of 9.4% this year is over double the increase we would expect to receive if the year-to-year increase in the total SSAF collected were distributed evenly among the student organisations. Given that the costs of other student organisations grow at a rate comparable to our own, we can expect that future SRC increases are more likely to be closer to the percentage increase in the total pool than not.

- 2. The current SSAF allocation process which guarantees organisations 90% of their funding from the previous year promotes stability and the status quo at the expense of flexibility. In short, the limited amount of negotiated funds makes it close to impossible for an organisation to gain a drastic increase in funding. This limits organisations from undertaking large new projects and may present a problem for the SRC in the future when it becomes necessary to employ an additional caseworker or Office Bearers decide to pursue a new major project.
- 3. This year, for the first time, negotiations between student organisations were unsuccessful and a University committee decided the final allocation of the SSAF. This is evidently undesirable from the perspective of maintaining student control of the distribution of student funds. Of equal concern is the unpredictability of future decisions made by this committee if negotiations in 2016 and beyond are unsuccessful. It is possible that the Committee will consider the increase given to the SRC in 2015 to be a necessary one-off boost which will not be repeated. Given that there is no precedent for the Committee's decisions and organisations were not given the opportunity to meet with the Committee we should avoid being reliant on a favourable decision from that group. We will be working with Kyol and the other student organisations to improve the transparency of the Committee process for next year. A secondary concern is the University's emphasis on project-based funding. Given that all but ~\$140,000 of the SRC's funding in tied to maintaining the organisation and its services, the SRC's plans do not generally suit a projectbased model. We were successful in identifying specific projects within our fixed requirements this year, but there is a risk that the committee will view the lack of "new" projects as a reason for less funding in future years.
- 4. The Vice-Chancellor has given the SRC assurances over the past two years that in the event of a partial or total loss of funding (e.g. the abolition of SSAF or the sudden disappearance of thirty of the University's thirty-four thousand undergraduates) the University would likely guarantee funding for the existing services of the SRC. It is therefore in the interests of students to incrementally increase service provision to match student demand such that a sudden loss of funding doesn't see the University fund our services at a level that is unable to meet the needs of the student body.
- 5. Matching income and expenditure this year will mean that future General Secretaries rely less on the outcome of SSAF negotiations to maintain the previous year's levels of funding to Office Bearers and services. (Well over half of our negotiated amount this year was required merely to continue the organisation in its 2014 form.) This will allow future Councils more freedom in seeking to expand or improve the SRC.

Changes in the 2015 Budget

While we were able to secure an increase of \$141,750 this year, a sizeable amount of this is automatically committed to covering:

- the standard annual increase in CPI;
- wage increases for casework, administration, publications and secondhand bookshop staff mandated by our Enterprise Bargaining Agreement; and
- changes in staff costs maternity leave etc.

These are necessary in order to ensure the continued provision of essential services by the SRC. Aside from these unavoidable costs, changes from the 2014 budget are listed below.

Increased funding to the SRC Legal Service

The Legal Service has become an essential resource for the undergraduate student body, Office Bearers and activists. The Service has consistently faced extraordinary increases in demand, including an increase in the total client load of 23% from 2013 to 2014, and a 42% increase in full case matters from 2010 to 2014. Two solicitors are currently employed at the SRC Legal Service for 4 days per week. Over the past year both solicitors have often worked overtime without pay in order to meet the demand for assistance from students. An expansion of the service is necessary to meet student demand, ensure that the Solicitors continue to have time to assist the President and other members of the SRC with legal matters, and meet our obligations to look after our staff and their working conditions. This increase in funding will expand the Legal Service by securing an additional day per solicitor, per fortnight (meaning one solicitor will available for appointments with students at the SRC each Friday).

Ten weeks of relief for the Casework Department

The Casework Department applied for funding to cover ten weeks of a caseworker wage. Intended for use throughout the year, this allows for the employment of a casual caseworker for ten weeks so that a permanent caseworker is able to complete training. *This will most likely result in a caseworker being accredited to give financial advice to students.* This service would obviously be of great help to a range of disadvantaged students. Further, training a caseworker for the ten week period gives that person the requisite training to act as a casual employee in the future. This fulfils the requirement of our Enterprise Agreement that the employer be prepared to provide casual relief for all staff members.

Casework Database

\$4000 has been allocated to replace the old casework client database. The old database needs to be replaced so that the caseworkers can meet their legal obligation to keep records. The ability to properly review caseload over time will also help the Casework Manager and future Executives accurately identify the department's needs.

Increased printing costs for student publications

Until 2015, Honi Soit was printed by MPD Printing. MPD offered their printing services for prices well below the nationwide market price. In late 2014, however, MPD became insolvent, meaning the SRC had to arrange for another printer for Honi Soit. The new, increased cost is the cheapest available and reflects the current economic pressure on

printing outlets. This also increased the cost for other SRC publications, including the Orientation Handbook, Counter Course Handbook and Growing Strong.

An increase of \$4174 for Office Bearers

This includes increased budgets for the following departments: Indigenous, Ethnic Affairs, Intercampus, Interfaith, Environment, Wom*n's, Sexual Harassment, Global Solidarity and Student Housing. Our decisions regarding how much funding each department would receive were based on estimated spending and details of their projects submitted by Office Bearers in their funding requests. It's particularly exciting that the Sexual Harassment Department, Muslim Wom*n's Collective and other historically less active departments have sought funding.

Decreased affiliation fee paid to NUS

This decrease accommodates the cost of expanding the SRC Legal Service, increasing Office Bearer budgets, and achieving the other projects outlined in this document while keeping the budget out of deficit.

Shared Resources Pool

A number of collectives requested funding for large items like projectors or megaphones that can be of use to the whole organisation, particularly other activists. To limit repeat spending and allow activists from smaller departments access to these resources, we have allocated \$3000 to be spent on shared resources—starting with a data projector and decent megaphones—that will be kept in the front office and loaned out to Office Bearers in the same manner as the tables are now. Any items that Office Bearers think we ought to have, or any spending they think should come out of this pool, please let us know.

Increased Stipend for Honi Soit

Unlike the stipends paid to Office Bearers (e.g. the President or General Secretary), the stipends of the Editors of Honi Soit do not increase year by year in accordance with the corresponding increase in the federal minimum wage. As such the stipend paid to Honi editors is, in real terms, smaller than the sum intended when a stipend of \$40,000 was adopted and continues to decrease. In recognition that stipends are paid to enable the participation of students from diverse backgrounds in student activities and the significant number of hours editors spend on the paper each week, an additional \$4000 has been allocated to Honi this year. This change in stipends must be formalised by a motion to executive, as per section 12(f) of the SRC Regulations.

Minimal Deficit

Please see the "Future Funding for the SRC" section of this report for an explanation of why budgeting for no deficit puts the SRC in a more secure position for the coming years.

Max: The VC was not at the meeting today, we were looking into the allegations made in the 4 corners report I assume you have seen or heard about it. Tyrone Carlin (university registrar) who is in charge of these things believes that the 4 corners is wrong and not pursuant to the University of Sydney, the report was based on an ICAC investigation in which the university meets the recommendations and exceeds in many areas, the one

where we don't meet the criteria it is where we use overseas agents where we don't have staff. There is still a better process here than the 4 corners report made them out to be

The second part of this, is we all so the email and the trumped up Sydney Morning Herald article that talking about looking onto plagiarism, so they've set up a Vice Chancellors plagiarism taskforce and have met and will be going about their business the next few months the creation of which was sparked by the Sydney Morning Herald article.

The only further thing that was mentioned which was Greg Robinson who is director of campus infrastructure is interested in getting students from the university in getting student to go with them around campus at night and getting people to show where on campus they feel unsafe so that can be identified and fixed, if anyone is interested in that please get in touch.

Chiara: We are really excited and have done a number of consults with collectives office bearers and the staff about what we are going to do budget wise. We are looking at the broader student movement having been at Nat Con and the president's summit and also international student organisers.

We have a lot of new faces coming in, this is exciting but also creates issues around continuity, we have no certainty about what we will be receiving next year. We would like more transparency in the process of the allocation of SSAF, we are looking into that over the rest of the term, we have included some numbers on further summaries to the SRC.

WE are excited about this budget as we are going to be extending that legal service to 9 days a fortnight. We are organising more training for caseworkers to offer better advice and expand services available to students. We have gotten increased printing for our student publications and there is an increase in funding to some of the smaller officer bearer positions allowing them to do some more work.

We've also invested in more capitol goods such as megaphones and projectors.

We have put a lager stipend to Honi Soit, this is because the other stipend has be set to minimum wages where as Honi's stipend has not changed.

All and all I think we have been able to achieve significant projects and we are excited and pleased about this.

O1. Report of Education Officers

Defend USYD Civil Liberties

We've been lending solidarity through printing and design work to the campaign in defense of several student protestors and a member of academic staff, Jake Lynch, who all face disciplinary action following a protest on campus. This campaign is all about defending freedom of speech and protest and BDS, and it has attracted national media attention for this reason.

We note the university's proclivity for bowing to conservative forces, whether that be the Chinese government not wanting the Dalai Lama to talk about Tibet on our campus, or Reclaim Australia and The Great Aussie Patriot not wanting the Socialist Equality Party's anti-militarist forum over the ANZAC day weekend, again reflected in the witch hunt following the protest of the Richard Kemp lecture. The Federal Budget

The next massive day for the education movement will be May 12th when the Federal budget will be released. A number of groups have planned a number of actions around this date. These are their stories.

Students Strike Back - May 12

The NSW Education Action Network has planned for a rally on the day of the budget, Tuesday May 12. This will take place at Town Hall at 2 PM, demanding no uni funding cuts, no course fees, and no cuts to welfare. Most of what's in the budget will likely be leaked or predicted which is why the rally is when it is. We'll be leaving the EAG at 1:30 to go to it, please come along!

NDA Building Day - May 13

The day after the budget, next Wednesday, the EAG will be on Eastern Avenue for a building blitz in the middle of the day. We welcome everyone to come along and participate in whatever it is we're

doing to bring attention to the education movement and the struggle against the government, specifically to build for May 20.

National Day of Action - May 20

NUS has called their next National Day of Action to be a week after the budget, on May 20. This is the day of the USU elections, so the EAG will be calling on all USU campaigns to cease campaigning for the duration of the NDA, to send campaigners to the NDA, and to encourage campaigners to advertise the NDA. I believe this had a positive effect on turnout at the massive post-budget NDA last year. Further details to come following a meeting with the *NSW Education Action Group* today.

David Shakes: One thing I was not able to add to the report is that there is an action tomorrow at one at the supreme court NSW for MUPRA, it's important to show support because this is a case of a university shutting down a student run organization and it completely disrespects the idea of student organizing, shutting down opposition to the university.

O2. Report of Wom*n's Officers

Apologies that this is our first official SRC Council Report, although we have tried to keep our Honi Reports as comprehensive as possible. In the interests of expediency we'll keep this as concise as possible and limit this to the last month.

Current/Recently Completed Projects

We're working on a few campaigns/initiatives at the moment –

- 1. Reproductive Rights inspired by Collective discussion following Life Week, we are currently designing posters to put up around campus to show solidarity with students who may have felt victimised by Life Week. The focus of the posters is to be as intersectional as possible, also making them a good information source. Our postering has been slightly delayed because of the weather. This was also complemented by our discussions about Purvi Patel the woman in Indiana who was sentenced to 20 years for a miscarriage. We've sent a letter to Indiana from the collective expressing our solidarity and concern.
- 2. Forced Closure of Aboriginal Communities We've decided to follow the SOS Blak Australia campaign and are sharing a photograph that we took after a collective meeting. A number of our members attended the National Day of Action on Friday as well.
- 3. Nepal Relief We set up a box in the Wom*n's Room for donations to give to Guthi Australia. We're also holding an event this Thursday, a Nepalese film screening to raise more money/collect donations.
- 4. USYD Feminist Education Groups this has been an ongoing project since early in the year. We've just collated all the activities/documents that will be taken to schools to propose our workshops. They are essentially a series of volunteer run feminist workshops that teach students about

- intersectionality/feminism. The final document to the schools is 5000 words so it's been a pretty comprehensive project/a lot of effort has gone into it.
- 5. Sexual Harassment Campaign We've met with the university administration and are currently collecting information for the website that will be launched, as well as looking to collective for feedback on the survey questions that will be asked of students.
- 6. Health & Wellbeing Day Self-Defence Workshops one of our collective members Aliza Chin is running the physical element with a discussion led by Monique Newberry that is on tomorrow (Thursday, 7th), USU Health and Wellbeing Day.
- 7. NOWSA We're facilitating attendance by students who want to go to the conference. One member is actually hoping to (she has registered) run a workshop. We may be funding some students partially, but this depends on how much money the USU is able to give (TBC).
- 8. Wom*n's Honi Soit We're currently working on bringing Honi together which goes on stands the week of May 28th. We have Indesign and Photoshop training for our editorial collective on Thursday (7th May) for this.

That's probably not everything but covers a lot of significant things. We've also been helping the USU with a range of initiatives, providing feedback on the following issues –

- 1. USU Sensitivity Training surveys to collective about how they feel about the USU and how they believe sensitivity training should be run.
- 2. Brosoc Collective discussion and a submission of opinions to the USU which will hopefully be considered before/if Brosoc becomes a society.

Budget

Our budget application is a lot more than was previously allocated. The year before went over their allocated amount and we felt it was necessary given that our O-week materials alone cost us over \$1000. These materials have been really good for getting people involved/interested in the collective (we've had a good, consistent turn out) and we have made back over \$500 which is not accounted for in our budget proposal. We're investing in long term projects for the collective – like re-stocking the library, and have also allocated quite a lot of money to cross-collective/intersectional collective activities.

It is probably unlikely that we will spend the full amount but thought it would be safe to budget more just in case. Writing down all planned events may also encourage us to do them all! Recently we haven't been spending as much money because most of our campaigns have been low cost. We are aware of keeping costs down and should finish the semester in a good place.

Q4. Motion re Aboriginal Action June 1

I direct Council's attention to webpages such as www.shut-down-australia.com, www.sosblakaustralia.com, amongst others. A planned action on June 1 is for Australians to "down tools for Aboriginal rights." It calls for Australians to "give 60 minutes for a people that have been here for over 60,000 years [in order] to stop the forced closure of Aboriginal remote homeland communities."

It goes on: "The time is now to stop the government from under resourcing and stripping essential funding to sustain community municipal services, such as water supply, electricity infrastructure, sewage services and garbage disposal for an estimated 200 remote Aboriginal homeland communities in WA and SA. Strike Action is to take place for 60 minutes between 10:30am to 11:30am the 1st of June 2015."

They are calling on all Australian workers to down tools for black rights.

So far, the rallies in April and May have attracted thousands upon thousands of marchers in solidarity with Aboriginal peoples whose community face forced closures for their "lifestyle choices".

Additionally, the campaign is calling for donations. I have included an action point regarding donations to the campaign—I would like Council to seriously debate this point and consider the amount we are able and willing to give.

Action Points

- · That Council acknowledges the long history of oppression of Aboriginal peoples.
- That Council fully endorses and stands in solidarity with the planned national strike actions on June 1, between 10:30 and 11:30am.
- That Council condemns the forced closures of Aboriginal remote communities and restates its commitment to Aboriginal rights and sovereignty.
- That Council directs its members and officers to promote awareness of the June 1 action to University of Sydney students and other parties
- That Council donates \$500 to the SOS Blak Australia campaign
